

**2019 Keystone Behind the Sign Giveaway
Official Rules**

**NO PURCHASE NECESSARY TO ENTER OR WIN.
A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.**

1. **Eligibility:** The 2019 Keystone Behind the Sign Giveaway (the "Promotion") is open only to legal residents of the United States, the District of Columbia (excluding Hawaii), and Canada (excluding Quebec) (the "Territory") who are 18 years of age or older and located in the Territory at the time of entry. Kampgrounds of America, Inc. ("Sponsor"), Sponsor franchisees, Keystone RV Company, SweepstakesPros ("Promotion Administrator") and their respective parents, subsidiaries and affiliated companies, retailers, sales representatives, dealers, distributors, licensees and the advertising, fulfillment, judging and promotion agencies involved in the development and administration of this Promotion and each of their respective officers, directors, employees and agents (collectively, "Promotion Parties"), and their immediate family members and persons living in the same households of each (whether related or not) are not eligible to participate. The Promotion is subject to all applicable federal, state, provincial/territorial, municipal and local laws and is void outside the Territory and where prohibited by law.  - a. **Online Entry:** During the Promotion Period, go to www.behindthesigngiveaway.com or the promotion application on the KOA page on Facebook, www.facebook.com/KOAKampgrounds (the "Websites") to locate the official entry form. Follow the on-screen directions, complete all required registration fields and submit to enter ("Online Entry"). You will receive one (1) entry in the Promotion for each Online Entry received. Entrants must complete all required information. LIMIT ONE (1) ONLINE ENTRY PER PERSON/EMAIL ADDRESS PER DAY.
 - b. **Share Entry.** After you have entered the Promotion, you may earn an additional entry by sharing the Promotion on Facebook or Twitter (a "Share"). Click on the Facebook or Twitter share link on the Websites and tweet the post from your Twitter account or share on your Facebook timeline (each a "Share Entry"). Each tweet or Facebook post must contain the hashtag #KOASweepstakes. You will receive one (1) entry in the Promotion for each person that enters the Promotion via Online Entry after clicking on the link in your Share. You will receive a Share Entry: a) only once per referred friend; b) only the first time your friend successfully enters the Promotion; c) only if your friend has not previously entered the Promotion; and d) only if your friend enters the Promotion via Online Entry immediately after clicking on the link contained in your Share. You may only refer persons with whom you have an existing personal relationship and with whom a message from you would not be considered spam.  - c. **VKR Membership Entry:** Enroll for a KOA Value Kard Rewards ("VKR") membership or maintain a current VKR membership valid through the last day of the Promotion Period to receive ten (10) entries in the Promotion ("VKR Membership Entries"). - d. **Mail-in Entry: To obtain entries in the Promotion without making a KOA VKR membership purchase**, legibly handprint your name, street address, city, state or province, zip or postal code, telephone number, complete e-mail address on a standard 4" x 6" postcard (with no outer envelope) and mail to: The Keystone Behind the Sign Giveaway, PO Box 18813, San Jose CA 95158 to receive ten (10) entries in the Promotion ("Mail-in Entries"). Mail-in requests must be received by June 7, 2019. All Mail-in requests must be legibly hand written (including addressing), mailed separately with no outer envelope and have sufficient postage. Promotion Parties assume no responsibility for lost, late, misdirected, stolen, illegible, inaccurate, damaged, incomplete, non-delivered or postage-due mail; or for failure or unavailability of electronic equipment, communications or Internet connections; or other errors, failures or malfunctions of any kind. All entries become the exclusive property of the Sponsor and will not be acknowledged or returned except as provided herein. Entries which are incomplete, incorrect, incomprehensible, not received, or do not otherwise comply with these Official Rules will be void and will not be entered into the Promotion's prize drawing. Entries made by any other manner not specifically allowed under these Official Rules will not be entered into the Promotion and may result in disqualification of the responsible entrant.
